INFORMATION ON THE PRINCIPLES OF PROCESSING OF PERSONAL DATA OF PARTICIPANTS IN THE EUROPEAN MOTORBOAT CHAMPIONSHIPS

Pursuant to Article 13 (1) and (2) of Regulation (EU) 2016/679 of the European Parliament and of the Council of April 27, 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation - Official Journal of the EU L 119 - hereinafter: RODO), I inform you that:

- 1) The administrator of the personal data of the participants of the European Motorboat Championship in the OSY-400 and GT-30 classes is Miejski Ośrodek Sportu i Rekreacji w Chodzieży registered office: 64-800 Chodzież, 12 Stanisława Staszica Street (hereinafter: MOSiR in Chodzież), REGON: 000917112, NIP: 7642221812, phone +48 67 282 02 49, e-mail: mosir@mosir-chodziez.pl.
- 2) The scope of personal data of the participant of the competition, which are or may be subject to processing by MOSiR in Chodzież, includes: name, date of birth, nationality, address of residence, e-mail address, telephone number, starting number, national representation/club, license number and date of its issuance and signature of the competitor, as well as contact details of the person designated by the participant, who should be notified about random events.
- 3) We process participants' personal data for the purposes indicated below and on the following legal grounds:
 - documenting activities related to the organization, conduct and promotion of the European Motorboat Championship in the OSY-400 and GT-30 classes and for the promotion of the competition in subsequent years within the framework of the Data Controller's legitimate interest in organizing the competition, including supervising its conduct and ensuring the safety of its participants (legal basis: Article 6(1)(f) RODO);
 - announcing and publishing the results of competitions and awarding prizes for the results obtained during them, including on websites and social networks, in the press and other media, as part of the Data Controller's legitimate interest in organizing competitions, including supervising their conduct (legal basis: Article 6(1)(f) RODO);
 - to update and correct the personal data of participants in the competition, as well as to contact them regarding the implementation of their requests, complaints, complaints, comments and demands, as part of the Data Controller's legitimate interest in handling the aforementioned requests, defending our rights and improving the quality of the services we provide (legal basis: Article 6(1)(f) of the DPA);
 - conduct financial settlements on the basis of applicable laws (Article 6(1)(c), (e) RODO);
 - securing information in the event of a legal need to prove facts as part of the Data Controller's legitimate interest (legal basis: Article 6(1)(f) RODO);
 - to establish, pursue or defend against claims being the realization of the Data Controller's legitimate interest (legal basis: Article 6(1)(f) RODO);

• to document - in situations that require it - the health status of competition participants (legal basis: Article 9(2)(a), (f), (g), (i) of the DPA).

If a participant of the competition gives additional consent for the use of his/her image on the websites https://www.mosir-chodziez.pl and FB MOSiR in Chodzież or in our information and promotional-marketing publications, then his/her personal data will also be processed by us in the course of conducting marketing activities through the communication channel selected by the person giving consent. The legal basis for conducting marketing activities by the Administrator in such a case will be Article 6(1)(a) of the RODO (i.e. the consent given).

- 4) Provision of personal data by the participant for the purposes referred to in point 3 above is voluntary, however, failure to provide such data may make it impossible to participate in the European Motor Water Championships, and in certain situations to realize other rights to which participants are entitled.
- 5) Participants in the competition whose data we process have rights:
 - access to their data and receive a copy of it,
 - rectification (correction) of data,
 - deletion of data (in accordance with the conditions set forth in Article 17 of the RODO),
 - to restrict data processing (in accordance with the conditions set forth in Article 18 RODO),
 - to data portability (in accordance with the conditions set forth in Article 20 of the RODO),
 - object to the processing of data (in accordance with the conditions set forth in Article 21 RODO),
 - lodge a complaint to the supervisory authority, which is the President of the Office for Personal Data Protection.
- 6) Personal data of the participants of the competition will be disclosed to the following data recipients:
 - co-organizers of the European Motorboat Championship:
 - ✓ Wielkopolski Powerboat and Water Ski Federation,
 - ✓ City Council in Chodziez,
 - ✓ Poviat Starosty in Chodziez,
 - ✓ Culture Center in Chodziez,
 - ✓ Water Rescue Team Chodziez Poland.
 - public authorities and entities performing public tasks or acting on behalf of public authorities, to the extent and for the purposes that result from the provisions of generally applicable law,
 - entities providing technical, IT and administrative services to MOSiR in Chodzież, including in
 particular: IT services, analytical services, maintenance services, archiving and destruction of
 documents, correspondence handling, consulting services, legal services, postal operators and
 courier companies, as well as the entity performing the tasks of Data Protection Inspector.

- 7) MOSiR in Chodzież will store the personal data of participants in the competition:
 - for the period of time necessary for the purposes referred to in paragraph 3 above,
 - for the period of recovery of claims in connection with the performance of the service,
 - for the period of performance of obligations under the law, including, in particular, tax and accounting, statistical and archiving.

In the case of processing for the purposes of the legitimate interests of the Data Controller (Article 6(1)(f) of the DPA) for a period until the data subject objects, subject to the need to process the data until the end of the period necessary to establish, assert or defend against claims;

In the case of data processing based on a person's consent - if the person withdraws his or her consent - (in the absence of any other legal basis for processing), or objects, we will cease processing the data for the purposes specified in the declaration of consent. In addition, we will keep evidence of the consent given for 3 years for the purpose of proving the facts in case of possible claims of incorrect processing of personal data by us.

- 8) Personal data of participants are not subject to automated decision-making by MOSiR in Chodzież, including profiling.
- 9) In matters of personal data protection, you can contact the Data Protection Officer appointed at MOSiR in Chodzież using the contact information indicated in point. 1 of this "Information".
